## Introduction

This paper provides a guide to the background, purpose, operation, and governance of the Greater Manchester Cricket League (GMCL) Accreditation Scheme for Grounds and Facilities. The GMCL Board will update the contents of the paper to incorporate future changes to the scheme.

## **Brief History**

At the inception of the Greater Manchester Cricket League, and indeed contained within the Prospectus which was published prior to the formation of the League, there was and remains a desire to improve standards of Grounds and Facilities in line with the vision of the England and Wales Cricket Board (ECB) for the recreational game.

All member clubs signed up to this approach as a condition of membership and by adopting the measures contained within the recently issued Memorandum of Understanding.

## **Purpose of The Scheme**

#### The purpose of this Accreditation Scheme is twofold

- To promote continuous improvement by recognising those clubs that continue to develop their ground and facilities irrespective of the level at which they are playing. This will be recognised by accrediting each club competing in the GMCL at the end of each season. Clubs will be accredited as Gold, Silver or Bronze.
- Clubs must achieve the minimum standards relevant for the tier that they are playing in or be working and making progress towards that standard.

Participation in the Scheme is a condition of membership of the GMCL.

## **Standards**

The Accreditation Standards are set out in Appendix 'A' and are in two parts,

• A1. The standards for Pitches, Outfield/Boundary and First Impressions, which are supported by performance criteria and a rating scale.

and

A2. Ground and Facilities.

#### **Assessment Procedures**

## A1 Pitches, Outfield/Boundary and First Impressions

The Umpires will, after each match, complete a standard marking sheet and these will be submitted to a designated person appointed by the GMCL who will collate all the scores and information relevant to individual Clubs.

This detailed information will be provided to all Clubs on a monthly basis throughout the season with the intention of allowing clubs to improve as the season progresses and to set plans for the medium and long term.

#### **A2 Ground and Facilities**

Standards will be identified as either assessed at pre-season or determined on a weekly game basis by the following methods:

- All grounds will be inspected by members of the GMCL Grounds and Facilities team prior to the commencement of the 2021 season.
  - This inspection will use the standards set out in A2 as a measure of a club's position for the Division that they are playing in.
  - This will be noted as requirements present or not and will serve as an action list for those clubs who
    do not meet the desired standard for the level that the club is playing at.
  - The inspection team will consist of appropriate people with appropriate knowledge and with no vested interest in the club inspected.
- Ground markings report, which are completed at the end of each match by the Umpires.

## **Monthly Performance**

The GMCL will use the information from the assessment reports to create an overall score for a monthly period, which will be reported month on month.

## Accreditation

At the end of the season each Club will be accredited Gold, Silver or Bronze (or unaccredited) by using the information measured over the season.

Three questions are addressed within each tier of Accreditation:

- Is the standard met consistently over the season?
- Is there the capability and capacity in groundsmanship to maintain the standard?
- What is the trend over several seasons? In Year 1 to be built up for the season and then subsequently
  moving to a trend over several seasons

#### Accreditation is only given when consistency has been demonstrated.

Once given, grading is not normally lowered or withdrawn based on a single season of lesser standard. It follows that grading is not normally improved or restored until consistency is proved over two or more seasons. However, exceptions may occur based on better or worse performances as may arise.

Prior to full accreditation, Clubs will be given interim grading levels for example: Silver with Gold potential or Bronze with Silver potential for Grounds & Facility grading only.

#### **Publication**

This accreditation scheme is used to provide clubs with a position of their relative and overall position and is to be seen as an incentive to improve. It is intended to publish this information widely and to reward those clubs who have made significant progress in achieving these standards.

Going forward we expect that the decisions around the allocation of Cup Final venues will take into account the ground standards of the clubs applying to host any cup final or representative game.

## Governance

The Standards are set by the GMCL and are heavily influenced by the Standards set for Premier League Clubs by the ECB. The Board of the GMCL manages and monitors the Grounds and Facilities Standards. Any disputes over matters of fact are open to review through the Leagues normal mechanisms.

A system of early warnings based on the match reports will be instigated to enable Clubs to remedy deficiencies against the standards.

External assessors will be appointed who will be available to the Board and the Clubs to agree any remedial actions.

## Promotion & Relegation

As previously stated, clubs must achieve the minimum standards relevant for the tier that they are playing in and this scheme provides the GMCL and its member clubs with a clear mechanism to understand what is required at each level. The League understands that to achieve these standards will, in some cases, involve a level of expenditure that requires budgeting for and to ensure clubs have time to plan, the scheme introduces a timeframe for improvement.

Nonetheless the GMCL are committed to applying these standards for the betterment of the game and as a result the following standards will apply across the GMCL:

- Premier 1 and Premier 2 Gold Standard
- Championship & Division 1 Silver Standard or Above
- Div 2A and 2B Minimum Bronze Standard & Moving to Silver
- Div 3W, 3E, 4N, 4S&W, 4E Bronze Standard or Above

If a Club's grading is lower than the standard set for each tier as detailed above, then Club's must make progress towards the relevant standard or risk being relegated or not promoted.

At the end of the current season, relegation to the next lower division can be imposed unless the Club submits a letter, by 1st September in that season, signed by the Club's Chairman and Treasurer, as well as any relevant documentary and/or financial evidence, confirming that the requirements for a grading relevant to the tier will be in place before the start of the following season or if agreed by the GMCL Board a longer period of improvement may be granted.

The above arrangements will be subject to confirmation by the Management Board of GMCL, who may confirm or vary the outcome, following the right of the Club to appeal. However, Clubs should not assume that leniency would be shown, where the raising of standards is concerned.

More details relevant to promotion and relegation are shown in the GMCL 2021 Season Information document updated 31st December 2020.

It will always be our intention to provide a promotion route for teams who are successful on the field, but we will make sure that those Clubs that are progressing are aware of the standards required for them to climb the league and play at a higher level.

Any club hiring or sharing a ground will be held to the standards of the ground at which they play. It is our belief that there should be a shared responsibility for the ground development so we would expect that the hiring club should at the very least support ground improvement events such as Cricket Force held by the host club and we will take into account the contributions made by hiring clubs.
