


# GROUNDS & FACILITIES

Greater Manchester Cricket League Accreditation Scheme for Grounds and Facilities **2024 SEASON** 











### **Background**

As an ECB Premier League, we are required by the ECB to ensure that standards in the top two divisions are of a high standard, and to report annually on the qualities of pitches and outfields. The required standards which are set out in this document are based on a set of requirements for Premier League cricket developed by the ECB and although these do not formally apply below the Premier Divisions, the League uses it as a basis for its expectations for all our grounds.

All member clubs signed up to this approach within the Memorandum of Understanding.

#### **Purpose of the Scheme**

The purpose of this Accreditation Scheme is to promote continuous improvement by setting achievable standards for clubs to attain for the following reasons:

- To recognise and reward those clubs that continue to develop their ground and facilities irrespective of the level at which they are playing.
- To achieve the standards for the tier that they are playing in to retain their place at that level, or
- To achieve the standards for the tier above to gain a place in the higher tier through promotion.

#### The Current Standards

The Accreditation Standards are set out in Appendix 'A' and are in two parts,

- A1. The standards for Pitches and Outfield/Boundary and First Impressions, which are supported by performance criteria and a rating scale.
- A2. Ground and Facilities Standards and Requirements at each tier.

This paper provides a guide to the background, purpose, operation, and governance of the Greater Manchester Cricket League (GMCL) Accreditation Scheme for Grounds and Facilities.

Participation in the Scheme is a condition of membership of the GMCL.

## A1 Pitches, Outfield/Boundary and First Impressions

The Umpires will, after each match, complete a standard marking form and these will be used by the GMCL to collate a live record of all the scores and information relevant to each ground for the season to date.

The summary of this information will be provided to all Clubs on an ongoing basis throughout the season via an online document to give an indicative score with the intention of allowing clubs to improve as the season progresses and to set plans for the medium and long term.

#### **A2 Ground and Facilities**

Scores and ranking will be determined from the GMCL Grounds and Facilities team assessment and the weekly game reports.

- Annual ground inspection by members of the GMCL Grounds and Facilities team prior to or shortly after the commencement of the season.
  - 1 This inspection will use the standards set out in Appendix 2.
  - This inspection will record requirements present or not, and will serve as an action list for those clubs who do not meet the desired standard for the level that the club is playing at.
  - The inspection team will consist of appropriate people with appropriate knowledge and with no vested interest in the club inspected.
- Weekly ground markings report, which are completed at the end of each match by the Umpires will cover some of the A2 facilities..

#### **Performance**

The GMCL will use the information from the Assessment reports to create an ongoing score, accessible online throughout the season and then, at the end of the season each Club will be accredited Gold, Silver or Bronze (or unaccredited) by using the information measured over the season.



GOLD Minimum 70% marks



SILVER Minimum 60% marks



BRONZE Minimum 50% marks

To generate improvement across the whole league the minimum requirements will be raised to 75%, 65% and 55% for 2025 and then by 2% annually.

## Three questions are addressed to finalise accreditation



Is the standard met consistently over the season?



Is there the capability and capacity within a ground's staff to maintain any improved standard?



If gradings are available over time, what is the trend, does it show improvement?

#### Accreditation is only given when consistency is demonstrated.

Once given, the annual grading is not normally lowered or withdrawn based on a single game or a group of games. It follows that a grading is not normally improved or restored until consistency is proved over time.

However, exceptions may occur based on **significantly** better or worse performances as may arise.

Prior to full accreditation, Clubs can be given interim grading levels for example: Silver with Gold potential or Bronze with Silver potential for Grounds & Facility grading only.

#### Governance

These standards are set by the GMCL but are heavily influenced by the standards set for Premier League Clubs by the ECB. The Executive of the GMCL manages and monitors the Grounds and Facilities Standards. Any disputes over matters of fact are open to review through the Leagues normal mechanisms but in the first instance contact should be made by email to Grounds@GtrMcrCricket.co.uk

Gradings at or below the level required will be highlighted in the online reports to enable Clubs to quickly see and remedy deficiencies against the standards; clubs are required to be proactive and review any issues flagged.

External assessors will be appointed who will be available to the Executive and the Clubs to agree any remedial actions. (is "external" the correct term? If they are from within clubs in the league, then I suggest not?)

#### **Ground Hire or Ground Share**

Any club hiring or sharing a ground will be held to the standards of the ground at which they play.

It is our belief that teams hiring or leasing a ground should demonstrate a shared responsibility for the ground development so we would expect that the players and committee of the hiring club should at the very least support ground improvement events held by the host club, and the GMCL will take into account the contributions made by hiring clubs in any judgements made.

#### **New Entrants**

New entrants to the league or new grounds used by existing clubs must be assessed before entry into the GMCL competition, so must be ready for inspection at the time of application in the season prior to the joining season, when an initial assessment will be given. Should the initial assessment not meet bronze standard then a full assessment must take place before the October 31<sup>st</sup> deadline required for fixture generation. If Bronze standard is not met, then the ground cannot be used in GMCL.

#### **Publication**

This accreditation scheme is used to provide clubs with an online view of their relative and overall position and is to be seen as an incentive to improve. It is intended to publish this information widely and to reward those clubs who have made significant progress in achieving these standards.

#### **Cup Finals**

Going forward the decisions around the allocation of Cup Final venues will take into account the ground standards of the clubs applying to host any cup final or representative game.

## **Meeting the Standard**

As previously stated, clubs must achieve the minimum standards relevant for the tier that they are playing in, and this scheme provides the GMCL and its member clubs with a clear process to understand what is required at each level.

The League understands that to achieve these standards will, in some cases, involve a level of expenditure that requires budgeting for and to ensure clubs have time to plan, the scheme includes a process to lay down a timeframe for improvement.

Nonetheless, the GMCL are committed to applying these standards for the betterment of the game and as a result the following standards will apply across the GMCL, relevant to the highest level team playing at the ground including rentals/ground lease.

The divisions previously listed were out of date, I would suggest the following

- Premier 1, Premier 2 & Championship Gold Standard
- Livision 1, Division 2 & Division 3 Silver Standard or above
- Divisions 4 and Divisions 5 Minimum Bronze Standard or above

#### **Promotion & Relegation**

If a Club's grading falls below the standard set for their current tier or is below the tier into which promotion is sought the club must be able to show they are making progress towards the relevant standard or risk being relegated or not promoted.

It will always be our intention to provide a promotion route for teams who are successful on the field, but we will make sure that those Clubs that are progressing on the field are aware of the standards required for them to climb the league and play at a higher level.

## **Failing Grounds**

Grounds not meeting bronze standard may not be used for GMCL games.

The Grounds and facilities team will meet with the club and enter into an agreement with the club and support them in every way possible to get the ground back on track.

## Time to meet the targets

Should there be issues, the Club may submit a letter, by 1st September in that season, signed by the Club's Chairman and Treasurer, including any relevant documentary and/or financial evidence, confirming that the requirements for a grading relevant to the tier will be in place before the start of the following season, the club should be proactive in doing this.

If agreed by the GMCL Executive a period for improvement may be granted, particularly where any possible immediate improvements would be wasteful in the context of longer term improvements already in progress.

The above arrangements will be subject to confirmation by the Board of GMCL, who may confirm or vary the outcome, following the right of the Club to appeal. However, Clubs should not assume that leniency would be shown, where the raising of standards is concerned.

In the event of a 'spinner' not bowling in the match and it is not possible to score 'Category — Turn', an average of the marks for the other three categories should be given to enable the calculation of the Total Pitch Score. I would prefer to do this automatically via the form to ensure consistency.

Umpires must make allowance for the abilities of the bowlers and wear and tear of the pitch during the afternoon

If unsure leave blank and make a suitable comment. (We cant do this – means manual intervention from us which we are trying to avoid)

I think we should add this table and associated questions to the captains' report, the ECB have said we should get feedback from captains on pitches.

A minimum of 50% of the initially scheduled overs at the start of a days play must be bowled for the Total Pitch Score to be used in the season's records. We need to have an entry on the form to cover this but is it really necessary to restrict the number of forms we get?

Umpires must make due allowance for the abilities of the bowlers and wear and tear of the pitch during the afternoon.

The scores are to be entered on the Umpires Report Form). Umpires must include a comment on the Report Card for a score of 2 or less for any of the four criteria or for a total score of 12 or less.
